1. RFP Attachment J.P-9, Model Individual Subcontracting Plan required two adjustments:
  - a. Tab 2 - The Small Disadvantaged Business Goal was corrected to match the RFP from 7% to 15%.
  - b. Tab 3 - the order of the “Goals by Small Business Subcategory” was re-ordered to allow the built-in calculation to function properly.
2. RFP Attachment J.P-10, GSA Form 527 was reformatted to resolve a technical compatibility issue with the A3 Proposal Intake System (Symphony). This amendment corrects the issue.
3. RFP Attachment J.P-12, C-SCRM References was updated to correct a file property error that affected the way the intended title was displayed. This amendment corrects the file title’s property in the PDF.
4. RFP Attachment J.P-13, C-SCRM Plan Template – The original template provided did not properly align to the C-SCRM Plan Preparation Guide. This amendment provides and updated C-SCRM Plan for contractor use that aligns with the Preparation Guide.
5. New Versions of J.P-9, J.P-10, J.P-12 and J.P-13 have been updated with a V.2 in the file name and uploaded to SAM.gov for use in final proposal submission. These versions of the files must be included in the final Proposal Submission.
